The purpose of the Jonesboro Police Department Monthly Report is to compile data into one integrated report for review, allowing for a seamless flow of information for better decision-making. After each department collates their monthly numbers and sends it to the Office of Crime Analysis, it is organized into sections of departmental data, analyzed and packaged, and finally disseminated to department heads, the Chief of Police, the City Mayor, and the City Council. Major sections include Crime Analysis, Emergency 911, Uniform Police Division, Prowl, Criminal Investigative Division, Warrants, Drug Task Force, Traffic, Parking Enforcement, Animal Control, Fleet Maintenance, Records, and Professional Standards.

CRIME ANALYSIS

The Crime Analysis division consists of one Crime Analyst and one part-time Crime Analyst Assistant. The Crime Analyst position is responsible for the analysis and dissemination of crime activity data and the collection and maintenance of crime intelligence information for the city of Jonesboro. Additionally, the Crime Analyst is charged with providing the department with current and accurate crime maps, presenting crime activity data to audiences of interest, and responding to requests for crime data from civilians and departmental staff. Data exported from this division is used by field agents for more effective, efficient policing, administration for improved staffing decisions, and the Mayor's office for community decision making and enhanced public relations. The following section is broken down into Total Crime, Crimes against Persons, Property Crimes, Crimes of Proactive Policing, Other Crimes, Arrest Demographics, Total Crime Monthly Comparison, and Next Month Predictions.

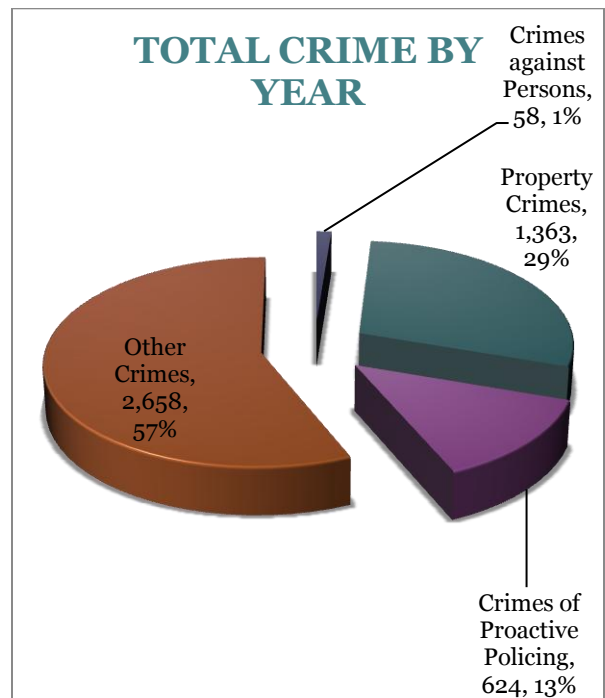
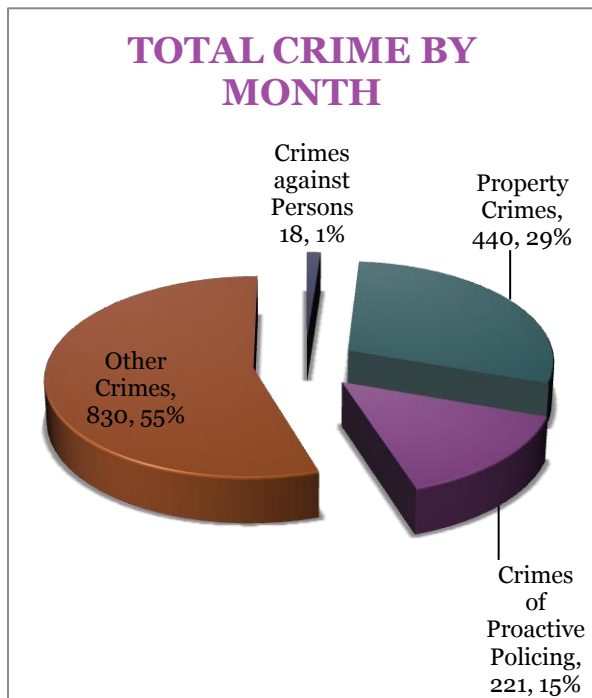

TOTAL CRIME

The crime activity for the month of March 2012 was at a total of 1,509 NIBRIS reportable offenses, a 13% decrease, comparing to a total of offenses in March last year. With Jonesboro population equal to 67,351, the crime rate was at 22 crimes per 1,000 population for the month of March this year, comparing to 26 crimes per 1,000 population last year¹, a 14% decrease. As indicated on a pie chart below, Other Crimes absorb the majority, 55%, of this month's crime activity ($n = 830$). Property crimes fall into a second place and comprise of 29% of all the crimes ($n = 440$). Following in third and fourth places are crimes of proactive policing at 15% ($n = 221$) and crimes against persons at 1% ($n = 18$), respectively.

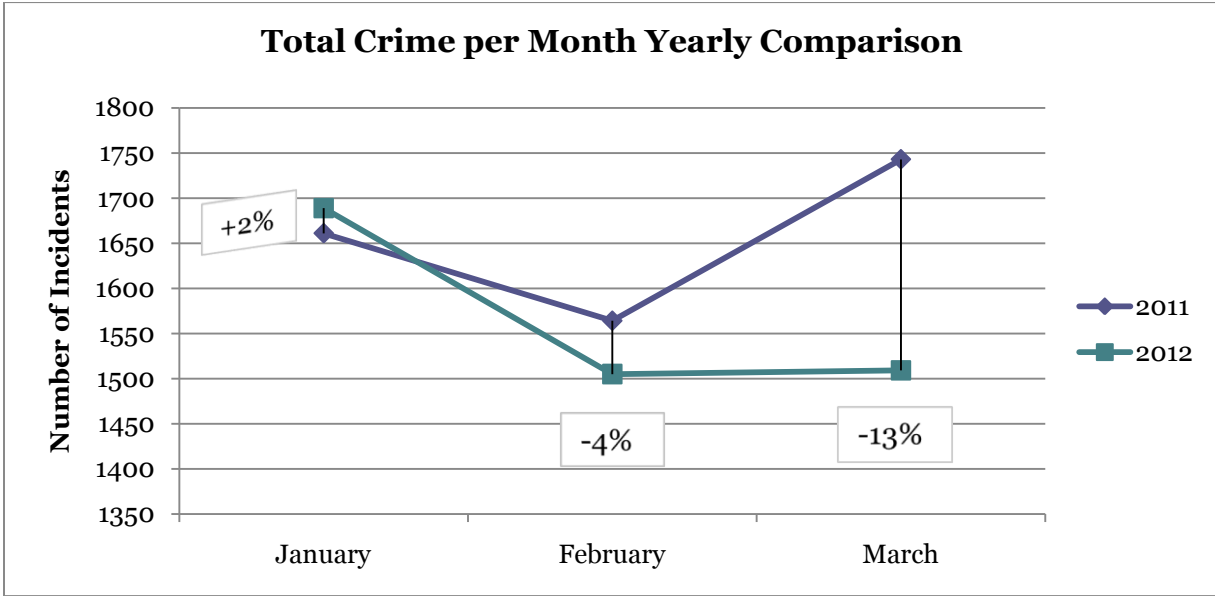
Year to date data includes number of crimes from January through March in 2012. A total of 4,703 NIBRIS reportable offenses were reported in 2012, a 5% decrease, comparing to the same period last year. The year to date crime rate is down 5% and amounts to 70 offenses per 1,000 population, compared to 73 offenses per 1,000 population last year. A 57% of the total crimes is attributed to Other Crimes category ($n = 2,658$). Property Crimes comprise of 29% of total crimes to date, where $n = 1,363$. Crimes of Proactive Policing amount to 13% ($n = 624$) and crimes against persons comprise of 1% of total year to date number of crimes ($n = 58$).

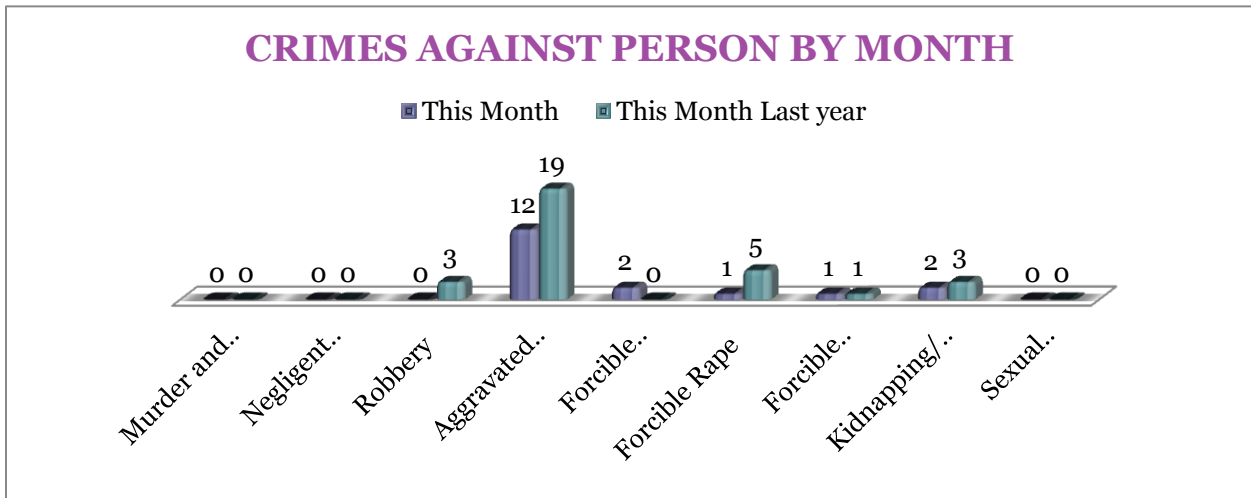

CRIMES AGAINST PERSONS

There are 9 crimes that make up this section. There were a total of 18 offenses in this area this month, up 42%, comparing to the last year's total in March. Aggravated Assaults are down 37%, no

robberies were reported this month and rape decreased 80%. As demonstrated on the bar chart below, there are no significant changes in other crimes for this category.

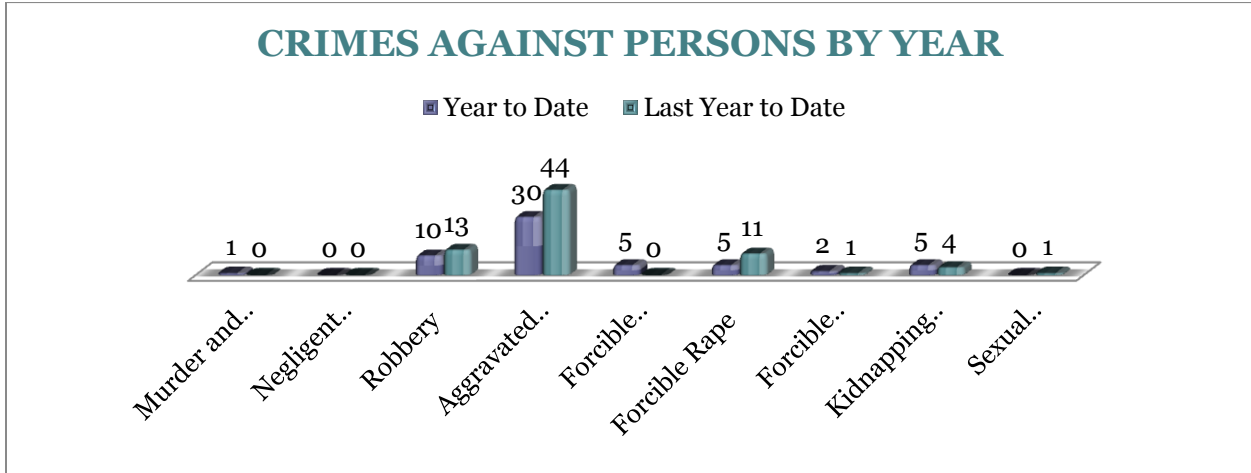


A bar graph on the following page shows the year to date data for Crimes against Persons, which amounts to a total of 31 incidents for this category of crimes, s 22%

decrease, comparing to the year to date data of last year. Aggravated Assaults are down 32%, robberies are down 23%, and forcible rapes are down 55%.

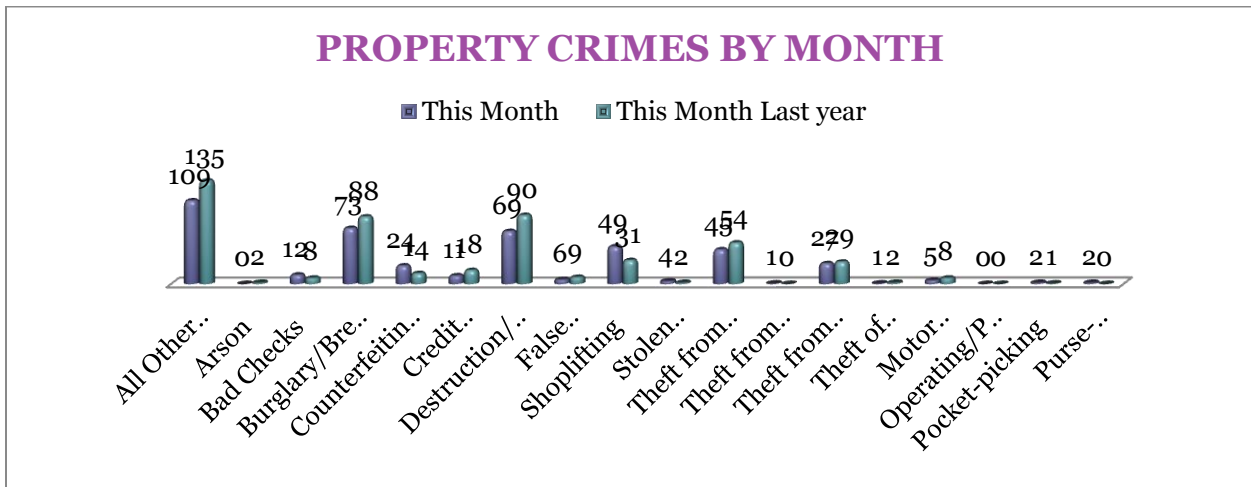

PROPERTY CRIMES

This section displays the criminal activity for 18 crimes, all against property. This month, there were a total of 440 Property Crimes, a 10% decrease comparing to March of the last year. The data indicates a significant change in

Destruction/Damage/Vandalism (down 23%) and Burglary/Breaking and Entering (down 17%). Counterfeiting/Forgery has increased by 71% and Shoplifting by 58%.

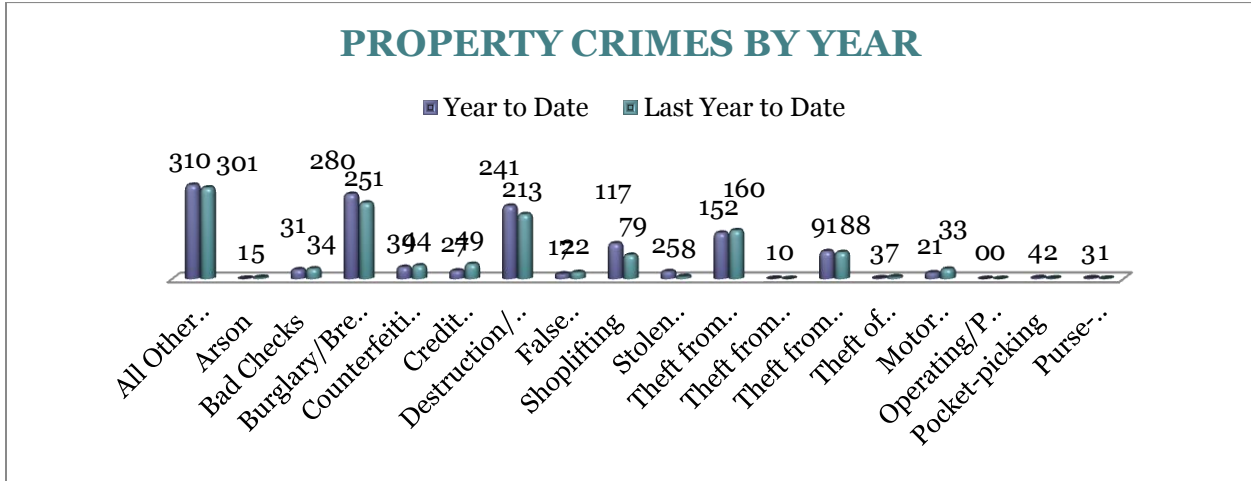


To date this year, 1363 property offenses have occurred, a 5% increase, comparing to the last year's data at this same time. The following significant changes are noted this year: Destruction/ Damage/Vandalism (up 13%), Burglary/Breaking or Entering (up

12%), Shoplifting (up 48%), and Stolen Property Offenses (up 12 offenses). Arson decreased by 80%The Motor Vehicle Theft decreased by 36%, and Credit Card/ATM Fraud is down 45%.

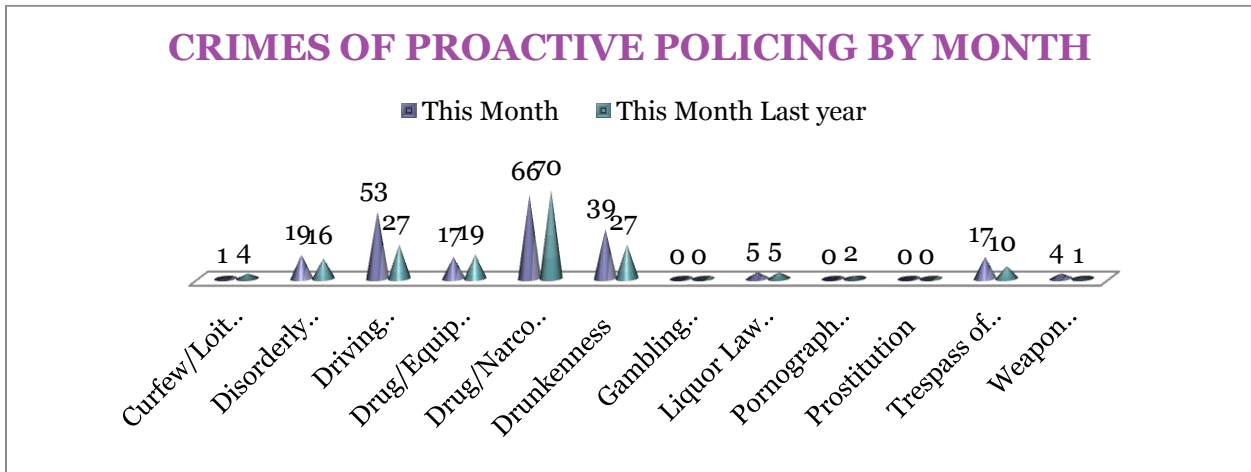

CRIMES OF PROACTIVE POLICING

Crimes of Proactive Policing are those crimes that result from police officers actively policing the streets to combat certain types of street crime. As a chart below indicates, twelve crimes fall under this category. A total of 221 offenses have occurred this month, a 22% increase,

comparing to March last year. There is a significant increase in Driving Under the Influence (up 96%), Drunkenness is up 44%, Trespass of Real Property is up 70%, and there were 3 more Weapon Law Violations reported, comparing to March of the last year. Drug/Narcotic Violations are down 6%.

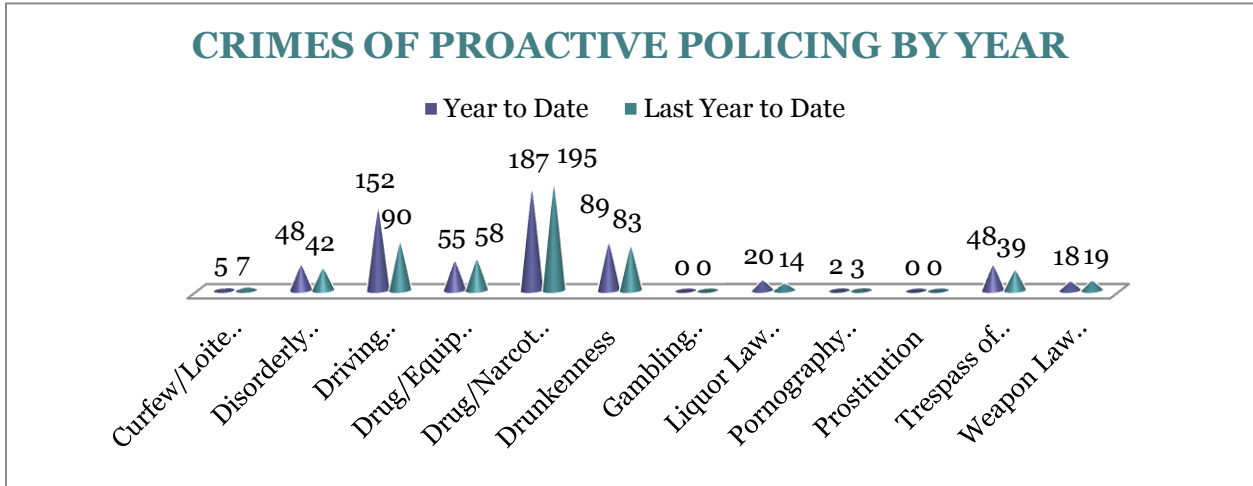


To date for the year 2012, there have been 624 crimes of proactive policing reported, a 13% increase, comparing to the last year's to date data. Driving Under the Influence is significantly higher than at the

same time last year (up 69%), Liquor Law Violations increased 43% this year, and Trespass of Real Property is up 23%. There are no statistically significant changes noted for other offenses in this category.

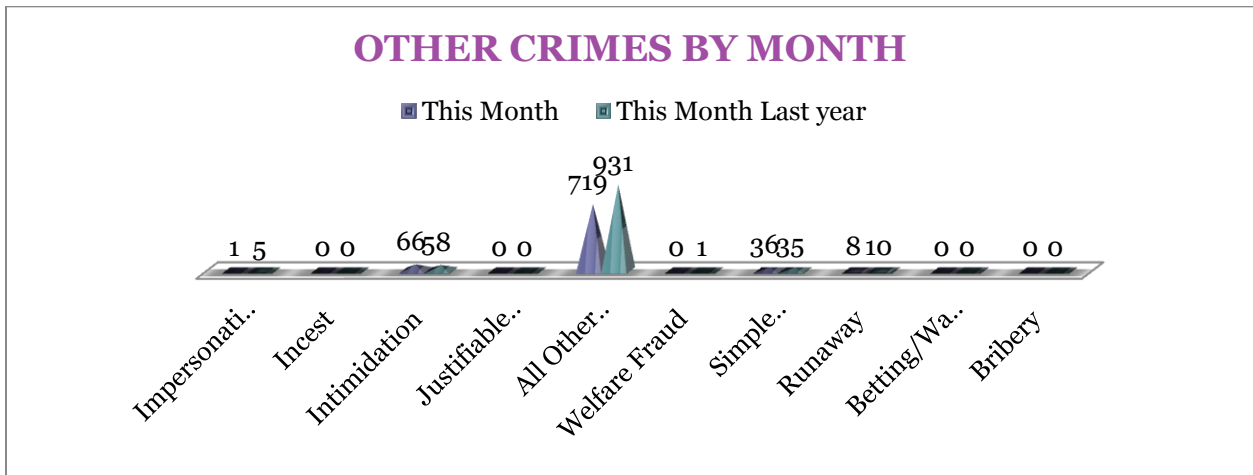

OTHER CRIMES

There are 10 crimes that fall into the Other Crimes category. This month, there have been a total of 830 Other Crimes, a 20% decrease, comparing to last March (n =

1040). Intimidation increased by 14%. All Other Offenses are 23% down. No other significant changes are noted in this category of crimes this month.

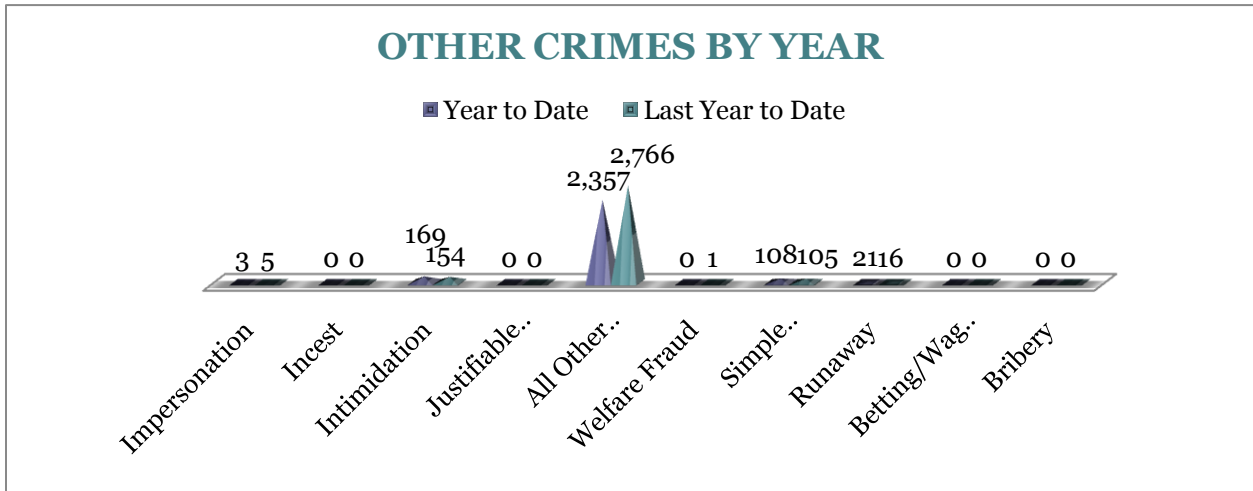


To date this year, there have been 2,658 Other Crimes offenses, a 13% decrease comparing to the last year's to date data. A notable change is observable for All Other Offenses that decreased by 15%,

while Intimidation is up 10%. No statistically significant changes have been observed for other offenses within this category, comparing to the last year's data.

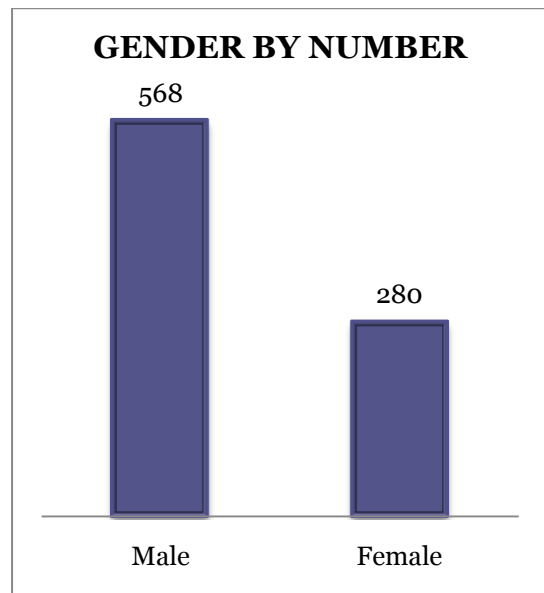
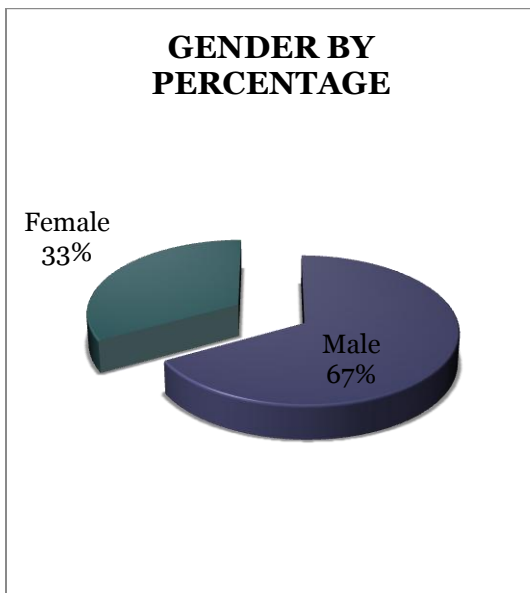

ARREST DEMOGRAPHICS

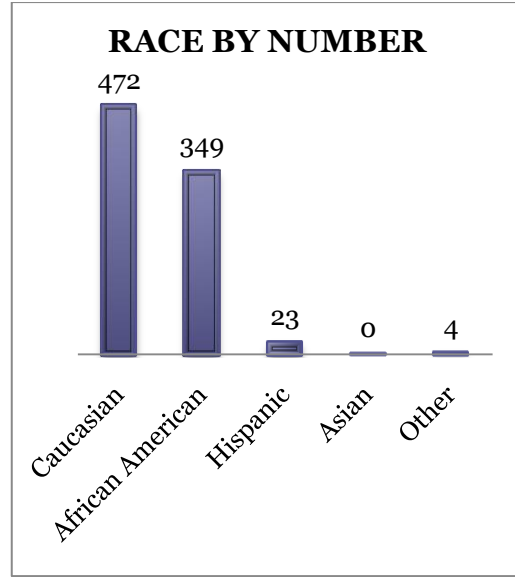
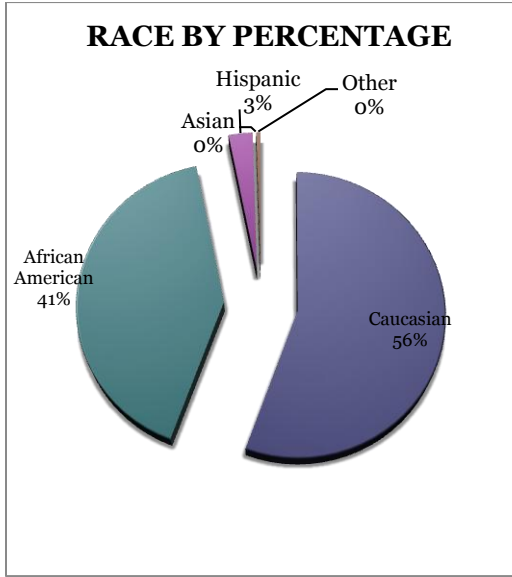
In March, there were a total of 848 arrests. Comparing with the last year's data for the month of March, there was a 12% decrease in arrests; that is 56 arrests per 100 crimes in March of this year, comparing to 55 arrests per 100 crimes last year, a 2% increase for arrests per 100 crimes. This

section breaks down this month's arrests by race and gender. The majority of offenders have been male ($n = 568$), as opposed to female ($n = 280$) and Caucasian ($n = 472$) and African American ($n = 349$) as opposed to Hispanic ($n = 23$), Asian ($n = 0$), or other/unknown/bi-racial ($n = 4$).



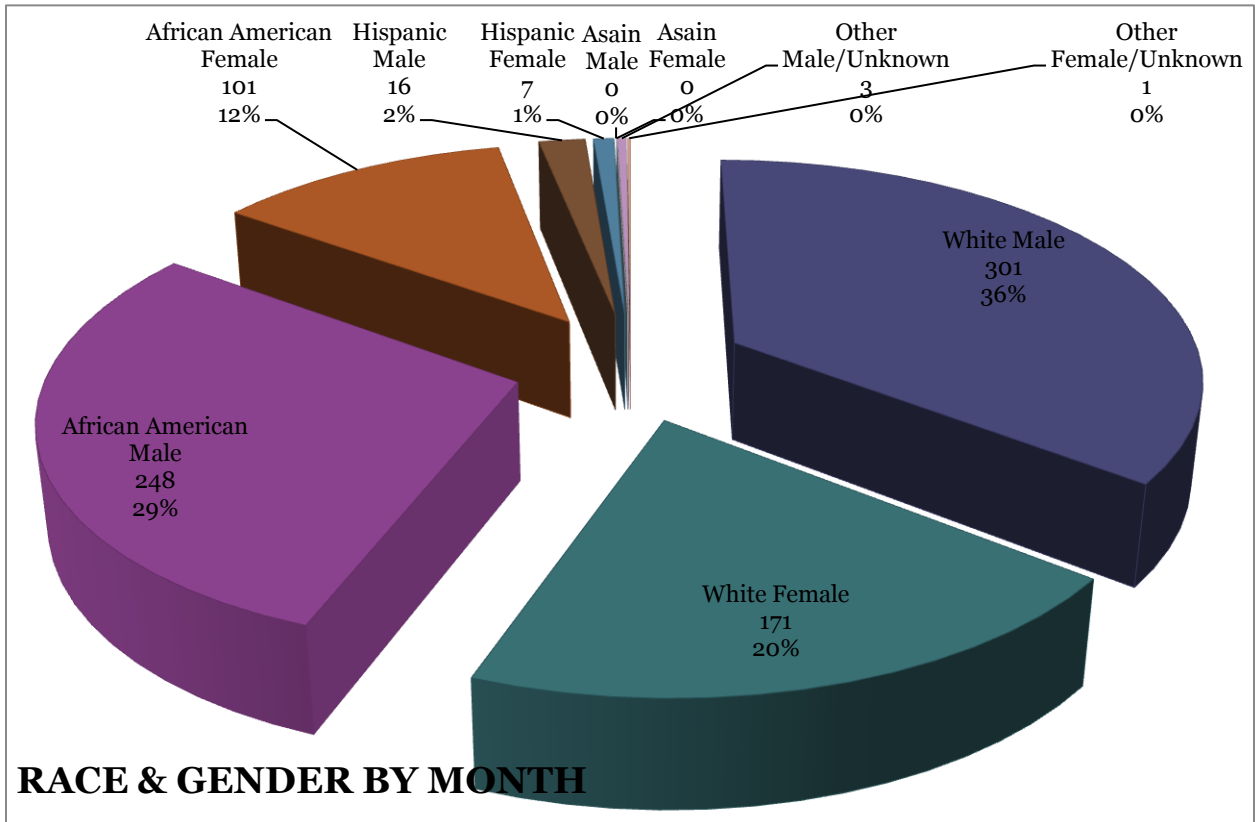

Caucasian males make up the majority, 36%, of arrestees this month ($n = 301$). African American males make up 29% of arrestees for the month of March ($n = 248$). Caucasian females make up 20% ($n = 171$)

and African American females make up 12% ($n = 101$). Hispanic males make up 2% ($n = 16$), and Hispanic Females make up 1% ($n = 7$) of arrestees.

EMERGENCY 911

Also known as Public Safety Answering Point (PSAP), the Emergency 911 Division is responsible for answering all calls from public for emergency assistance, accessing the needed information to best assist, and then assigning the most efficient and effective emergency response. In addition,

this division is responsible for setting priority call dispatching to field units including Police, Fire, and EMS. Emergency 911 also maintains all records for radio logs, calls for service, and other emergency service data collections.

UNIFORM PATROL DIVISION

The UPD is responsible for responding to calls into the Emergency - 911 Division by civilians and are normally the first responders. Jonesboro is divided into 6 patrol districts. Officers from UPD are assigned to a district and work the same

district every shift. In addition, when a Traffic Officer is not available, a UPD Officer will respond to traffic accidents and assist in directing traffic when necessary.

is responsible for transporting wanted persons arrested in other jurisdictions back to Jonesboro. The STEP program operates within this division and is a grant-funded operation in which officers can get paid overtime to enforce the safety belt law.

TRAFFIC

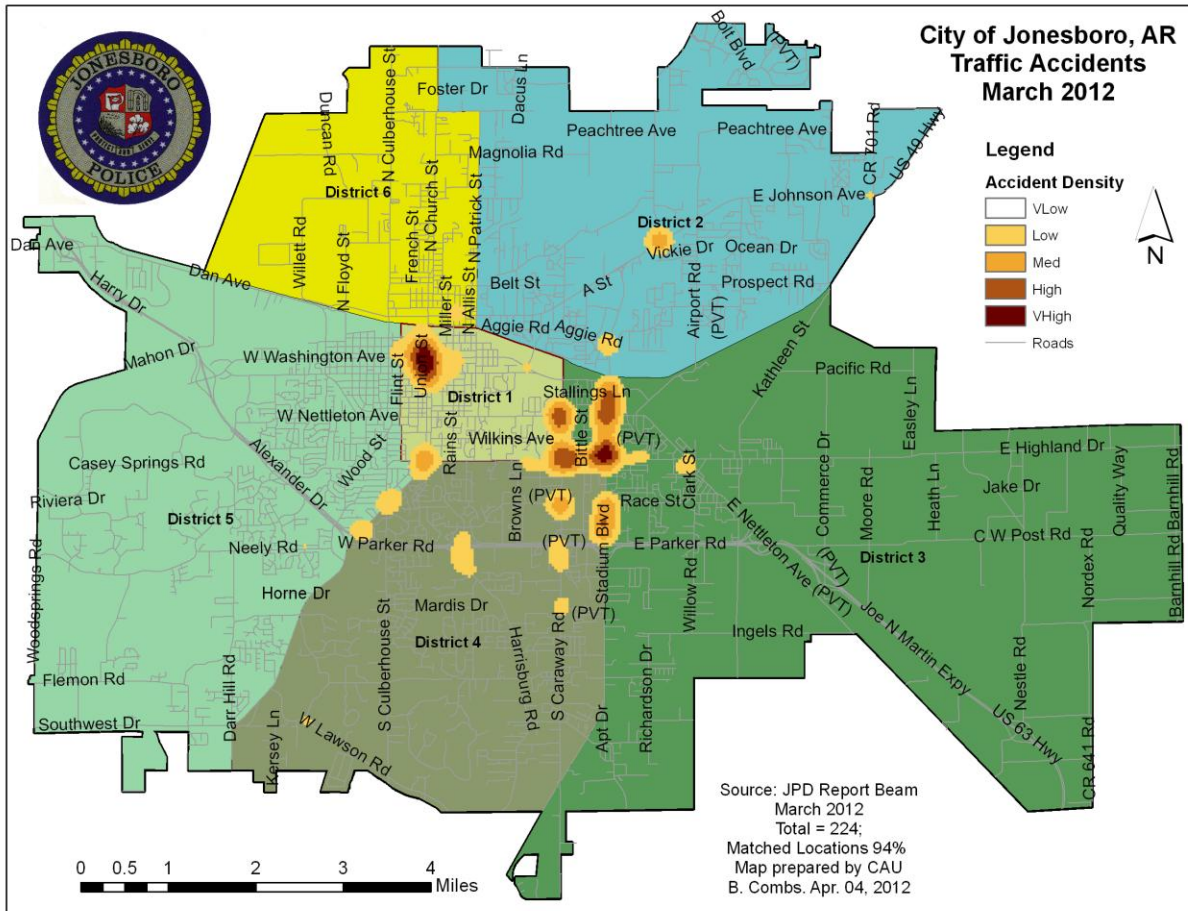

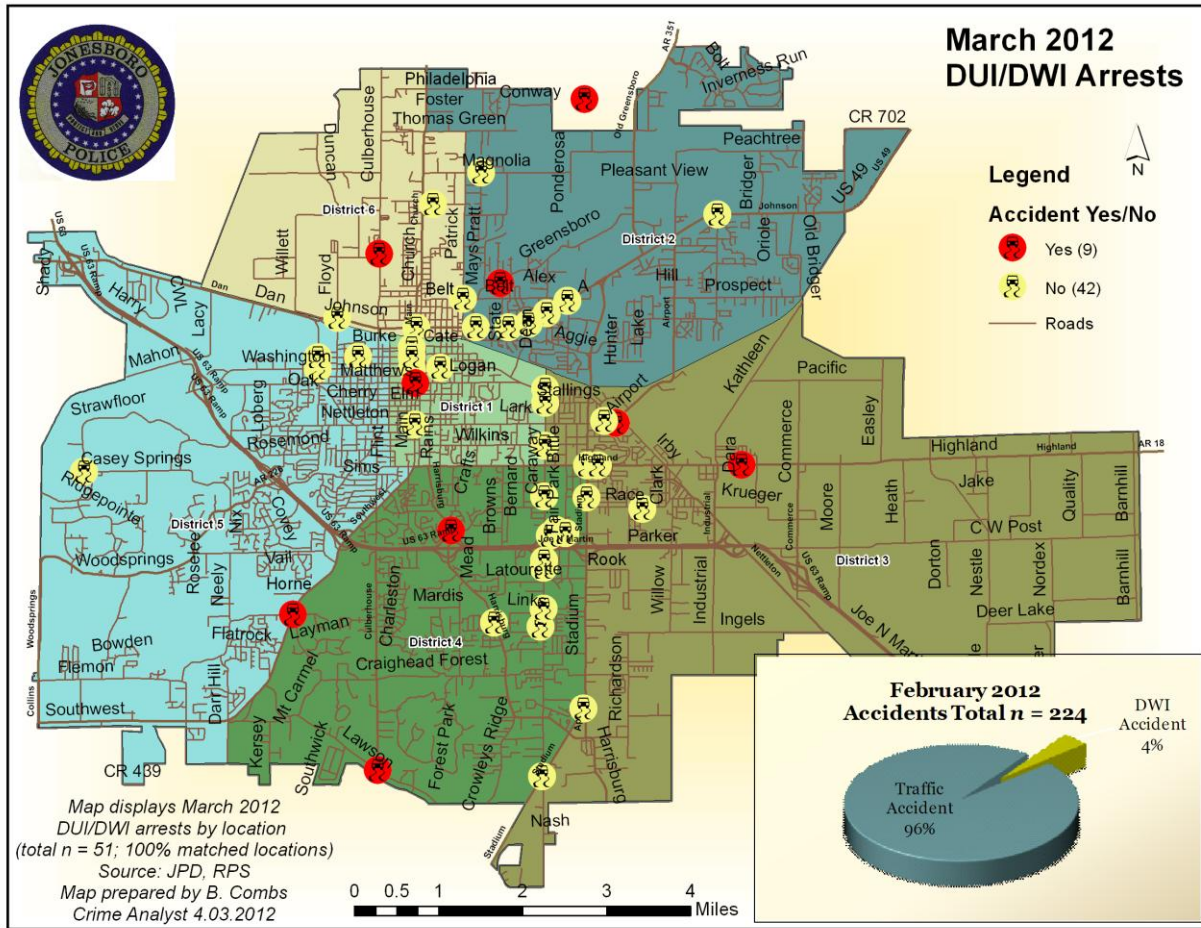

ANIMAL CONTROL

The Animal Control Division is responsible for educating the public on safe and humane issues regarding animal treatment, enforcing all animal laws and ordinances, assisting the public in resolving animal

issues, and protecting the safety and welfare of the citizens and animals in this community.
